# Data protection information for raffles

Verlag A.Vogel AG is a company based in Switzerland and is the responsible party within the meaning of the DPA and the GDPR.

### Purposes and legal basis for the processing of your personal data

The collection and processing of personal data is based on the provisions of the DPA and the GDPR. The legal basis for data processing in the context of the raffle is Art. 31 Para. 1 in conjunction with Art. 6 Para. 6 DPA or Art. 6 Para. 1 p. 1 a) GDPR. The personal data will be collected, processed and used for the purpose of processing the raffle.

## Data transmission within the group

The data will be shared within the group of the raffle company for administrative purposes. If data is exchanged within the group, this is done for the purpose of processing the raffle or on the basis of your consent. In addition, there may be an interest in passing on this data for internal, administrative purposes. If the processing of your data takes place outside of Switzerland or the EU/EEA, this transfer will take place in compliance with all applicable data protection laws, in particular appropriate safeguards within the meaning of Art.16 DPA or Art. 44 et seq. GDPR.

#### Data transmission to further recipients

A transmission to further recipients takes place. Should a transmission to further receptions take place, this will only be done insofar as this is necessary for the processing of the raffle. In doing so, we use service providers who support us in the implementation of the raffle. They act only on our instructions and process the data only for the specified purpose. Any use beyond this does not take place and requires legal permission or consent.

# Data transfer to a country outside Switzerland or the EU/EEA (so-called third country) or an international organisation

A data transfer to a third country or to an international organisation takes place. This only takes place if suitable guarantees exist in the sense of Art. 16 DPA or Art. 44 et seq. GDPR.
